Facilities Updates

The Board reviewed two presentations regarding possible solutions to cooling down classrooms during the warmer months.

The first presentation was on Air Conditioning Units in HCSD given by Larry Raffo who reviewed with the Board and the public the types of air conditioning units we currently have in our schools and the practicality of purchasing and installing portable air conditioners in individual classrooms.

The second presentation was by Mike Wasserman of Capital Project Management (CPM). His presentation focused on our "Cooling Pilot Project" installing fans in our classrooms and next steps.

The Board took action on the Cooling Pilot Project with fans and we will be moving forward with this using funding for this project through our Measure B Bond funds. Cost of this project is approximately \$86,000.

Matthew Lindner, Director of Educational Services, presented the results of the 2019 California Assessment of Student Performance and Progress (CAASPP), reviewing and comparing our scores to previous years and similar districts in ELA and Math.

Special Board Session

The Board held a Special Board Session at 4:30 PM to review site plans from QKA on the Facilities Master Plan that HCSD is currently in the process of developing. To date, QKA has held over 28 meetings with staff, parents and the community as a springboard for site designs. Over the last month, the team from QKA has been meeting with staff and parents to review the latest drawings. HCSD is currently in the process of finalizing the drawings and then moving forward with prioritization of projects.

Reorganization of the Board

Education Code requires that the Governing Board of each school district hold an annual organizational meeting the first part of December. At this meeting, the Board elects a president (35022), a vice-president and a clerk (35243). Tonight the Board elected and approved Trustee Geddis to continue a second term as President, Trustee Chen as Vice President and Trustee Dannis as Clerk.

- California School Boards Association Conference thank you to the Trustees who attended this event last week.
- Alexis MacAvoy (a former Crocker and South alum) is the recipient of the 2019 Broadcom MASTERS \$10,000 Robert Wood Johnson Foundation Award for Health Advancement. We congratulate Alexis, now a San Mateo High School Bearcat on her successful project which she completed at Crocker Middle School!
- 2020-2021 Enrollment:
 - Numbers are looking similar to last year (86 registered so far): 29 at North, 25 at South, and 32 at West. Current kindergarten enrollment: 117 students. (Last January, 89 registered during open enrollment. We have moved enrollment to December this year.)
- 2020-2021 District Calendar Update: The Hillsborough Teachers Association is currently voting on two options, will bring to the January meeting for approval by the Board
 - Likely highlights include a week for Thanksgiving Break, no school on Indigenious Peoples' Day (formerly known as Columbus Day), school ending on the second Friday in June
- Technology Infrastructure Update work continues as we move towards all campuses having upgraded technology with new clock, bell and speaker systems
- Turkey Trot great day for students and staff and thank you to our alumni runners!
- Assessed Property Values: 4.49% growth
